CryptoClips aggregates publicly available crypto-asset news and market data, transforms it via AI summarisation, and presents it in a short-form “clips” interface. We do **not** provide investment, legal, or tax advice. Content is “informational only.”

3. Eligibility & Accounts

You must be at least 16 years old and capable of entering a binding contract. You are responsible for maintaining the confidentiality of any login credentials and for all activity under your account.

4. User Conduct

You agree **not** to:

- violate any law or regulation;
- scrape, crawl, or reverse-engineer the Service;

- use the Service to manipulate markets or disseminate misinformation.
